Eastside Legal Assistance Program Mission and Overview

The **Eastside Legal Assistance Program (ELAP)** is a non-profit organization that provides **free legal assistance** to survivors of domestic violence throughout King County and **civil legal aid** to low-income residents in East, Northeast and Southeast King County.



Our impact in 2018:

- 486 survivors of domestic violence served
- 3,020 family members benefited from services
- 935 clinic appointments with volunteer attorneys
- 180 volunteer attorneys
- 1,434 pro bono hours

Our services include:

- **Advice Clinics**, including specialty clinics for family law, domestic violence, immigration, and bankruptcy issues
- **The Domestic Violence Legal Program**, providing extensive advice and limited representation for survivors of domestic violence using DV Staff Attorneys, and ELAP DV/Family Law Corps volunteer attorneys
- **Medical-Legal Partnership, on-site** collaboration with Sea-Mar Community Health Centers and International Community Health Services (ICHS) at their Bellevue, Washington clinics to address patients' legal needs.
- **Wills Clinics**, providing will preparation, powers of attorney, and physician's directives
- **Workshops and Know Your Rights lectures** for general help on various legal issues
