# Eastside Legal Assistance Program Mission and Overview

## ACCESS | EMPOWERMENT | HOPE

The **Eastside Legal Assistance Program (ELAP)** provides **no cost legal aid** to low-income residents in East, Northeast and Southeast King County.



### Our impact in 2019:

- 1,279 clients served at ELAP
- 530 survivors of domestic violence served
- 910 clinic appointments with volunteer attorneys
- 161 volunteer attorneys
- 1,434 pro bono hours

### Our services include:

- **Legal Advice Clinics**, including specialty clinics for family law, domestic violence, immigration, and bankruptcy issues
- **Wills Clinics**, providing will preparation, powers of attorney, and physician's directives
- **The Domestic Violence Legal Program**, providing extensive advice and limited representation for survivors of domestic violence using DV Staff Attorneys and volunteer attorneys
- **Medical-Legal Partnership**, addressing patient's legal needs in a medical clinic setting to disrupt negative social determinants of health
- **Kirkland Housing Stability and Family Law Project**, addressing housing and family law issues for residents of Kirkland
- **Know Your Rights Workshops**, general education on various legal issues
